

Invest In Their Future Lottery

RULES GOVERNING OPERATION OF A RAFFLE

1. Draw will be held at the office of Stride Management Corp. located 3950 - 12 Street NE, Calgary, AB.
2. **The Invest In Their Future Lottery** draw will be held at 11:00 am the 2nd and 4th Friday of every month. The first draw will take place on Dec. 11, 2020 and the last Nov. 25th, 2022. If the draw date falls on a holiday, the draw date will be noted on our social media and website. Only ticket orders received at the Lottery Ticket Sales Centre before the **deadline of 11:59 pm the Wednesday prior** to the draw will be eligible for this draw. Ticket orders purchased after the deadline will be entered in the next available draw.
3. The draw is open to the public.
4. Prize draws follow a strict set of procedures, with draw control oversight by Stride Management Corp. and under licensing approval by the licensing body, the Alberta Gaming, Liquor and Cannabis (AGLC).
5. Two executive members and/or delegates will attend each draw virtually.
6. Winners will be notified via phone or email address they provided at ticket purchasing, detailing what they have won and where they can claim their prize. Winners are encouraged to view The Fort McMurray Boys & Girls Club website and social media in the case we cannot reach them. The name, city and winning ticket number will be published on the lottery website at www.fmbgc.ca/lottery.
7. Prize must be accepted as awarded and must be claimed within one year from the final draw date. If the prize remains unclaimed for more than one (1) year from the date of the draw, a request will be made to AGLC for a decision regarding the disbursement of the prize.
8. Contest guidelines prohibit the following people from purchasing tickets: The Lottery Manager, the Lottery Committee, employees of Stride Management Corp., immediate family of those listed above and anyone under the age of 18. A minor's name must not be on a ticket.
9. In the event a winning ticket stub has more than one name on it, the licensed charity shall award the prize to only one of the individuals identified on the ticket, and that the licensed charity and the AGLC are not responsible for any disputes which may arise between the different individuals whose names appear on the ticket stub.
10. **18,750 tickets available consisting of: 1500 single tickets at \$10 each, 1000 3-packs for \$20 each, 800 10-packs for \$50 and, 250 25-packs for \$100 for a total of 3550 ticket packages. There will be a minimum guaranteed payout of \$417 per draw (20% of license) or 50% of ticket sales, whichever is higher.**
11. Tickets may be purchased via Visa, Master Card, American Express, online, debit or cash, or e-transfer to lottery@fmbgc.ca. The Licensee's liability is limited to the purchase price of the ticket.
12. If a purchased ticket has been entered for any draw, no refund will be issued.
13. Only upon demonstrating extraordinary circumstances to the AGLC will the Licensee make a request for draw date extension. Minimum of 29 tickets must be purchased before requesting a draw date extension or cancellation of the raffle.
